## **OVERVIEW**

Within the scope of our Integrated Management System; "Whale is engaged in the business of the design, development, manufacture, marketing, sale, and delivery of pumps, water systems, and water and space heaters, for the RV, Marine, Domestic Shower Drainage and other niche markets." We at Whale recognise that providing our customers with a quality service whilst minimising our impacts on the environment and ensuring the safety of our staff are critical to our business. We are committed to providing the necessary resources to ensure we continuously improve our business practices within these core areas.

To achieve this, we have developed and will maintain an Integrated Management System that will meet the requirements of the current versions of ISO9001, ISO14001 & ISO45001.
